CANCELLATION POLICY

- Up to 14 days before departure full refund
- 2 14 days before departure 80% refund of booking value
- 24 48 hours before departure 50% refund of booking value
- Less than 24 hours before departure or NO SHOW no refund.

EXTRAS (baggage, sports equipment, pets)

- Passengers purchasing one way or return tickets are entitled to carry:1 (one) piece of luggage of not set size or weight and, 1 (one) piece of hand luggage of not more than 56cm x 45cm x 25cm in size and 10kg in weight. Handbag, briefcase, laptop, shop purchases, camera etc must be carried in your 1 (one) permitted piece of hand luggage.
- Please note that, due to regulatory restrictions, pets cannot be transported on the international maritime line between Dubrovnik and Budva. Passengers traveling with pets are kindly advised to use the land border crossing.
- Possible additional surcharge for luggage, handbag, briefcase, laptop, shop purchases, cameras etc. are permitted as extra piece of hand luggage, supplements for extra luggage are charged in the amount of 5 Eur and bikes 10 Eur. Prior announcement is required for bikes and ebikes are not allowed.

IMPORTANT NOTES

- Passengers are obliged to collect information on the necessary travel documents (visas and similar permits) and obtain them
- Valid Passport or EU ID is required for travel, following information name and surname, gender, date of birth, nationality, document's type and number is required at the time of reservation.
- Ship's master reserves the right to change the route or cancel the sail for justified reasons
- In case of cancellation the trip will be organized by alternative means of transportation (bus) valid for guests travelling in one direction, not on a daily trip.
- International transport exempted from VAT under Article 43, Paragraph 2 of the VAT Law, service related to international transport is VAT exempt under Article 47, Paragraph 1 of the VAT Law
